#### Introduction

In the Netcode elektriciteit chapter 6, article 6.2.4.1 the grid operator will handle correspondence from the connected party within 10 working days. This correspondence includes the cause of the malfunction, the rooth cause analyses and the measures taken. To gather this information , the 12-hour, 24-hour and 5-day reporting line was developed within TenneT's asset management. For this report a fixed template <TFRM-003 Template 12-hrs, 24-hrs en 5-day rap. 26-05-2020> is used. This appendix explains who is responsible for what by means of a RACI and the criteria when a report has to be made.
